TPR will charge this card for the balance due in the event that we do not receive your check by the start of the program or if your check is returned for insufficient funds.

REFUNDS: If you choose to cancel your enrollment seven or more days before the first session of your program, we will refund all of the tuition you have paid (including your deposit). If you decide to cancel your enrollment within six days of the first session of your program, we will refund all of the tuition you have paid less your deposit. No refunds will be given after the first session of the program in which you enrolled.
